In 2020 more than 10,000 Australians of working age experienced a stroke for the first time.

There are more than 445,000 Australians living with the impact of stroke. Without action by 2050, this number is expected to almost double to more than 800,000.

At the age of 34, Kate suffered a stroke.


Kate was flown to a Melbourne hospital where she received world-leading clot retrieval treatment – a procedure pioneered here in Australia with the help of Stroke Foundation supporters.

"I remember landing on the hospital's helipad and being wheeled inside. The next thing I remember is waking up in recovery," Kate said.

"The clot retrieval treatment had been a success. I realised I could speak and use my right side. This moment will be forever etched in my memory. Nothing in the world could beat it! I've been given a second chance."

Kathy and Dennis Harrison (Queensland)

In 1991, a week before Christmas, Kathy collapsed after getting out of the shower. She was only 47, but she'd suffered a stroke that left her unable to speak or swallow.

"I was powerless to help her," says her husband, Dennis.

Years of therapy saw Kathy start to regain some of the functions her stroke had taken away. But as she says, **"You never quite get over a stroke and what you've lost."**

Kathy and Dennis don't want stroke to keep taking away the things people love, which is why both of them have left a gift in their Will to Stroke Foundation.





Prof James Angus AO (Victoria)

When James was young, his grandfather had a stroke that left him unable to communicate with or recognise his loved ones.

"From a very young age, I saw the disability of this," James says. "If they had the drugs we have today, no doubt he would have survived. And he may not have had the stroke in the first place."

Seeing what his grandfather went through inspired James to become a world-renowned medical research scientist. James and his wife Helen have both left gifts in their Wills to ensure that future Australians don't have to suffer as his grandfather did.
