Five simple steps to remembering The Alfred in your Will

1. Talk to your solicitor or Trustee Company

The easiest way to go about including a gift in your Will is to seek the advice of a solicitor or Trustee Company offering a Will-writing service.

Simply hand this card to your solicitor when you next visit them and let them know you would like to name The Alfred as a beneficiary in your Will. They can explore your preferences and make sure your generous wishes are properly carried out.

2. Decide on the type of gift you would like to leave

Here is some sample wording to describe the type of gift that you'd like to include in your Will or codicil (an addition to your Will):

4. Other things for you to consider
